

FCF COVID-19 SELF-ASSESSMENT HEALTH DECLARATION TEMPLATE

FCF follows the advice and instructions of State Health Departments of the current Coronavirus COVID-19 situation to ensure our church members and Pastoral team have up-to-date and accurate advice.

ALL volunteers, members and guests who will be attending in-person gathering are required to complete this form before entering the church building on Sunday every week, so that FCF's leadership can determine current level of exposure to COVID-19 and take further precautions to reduce the risk to all in attendance.

Completing this section is **MANDATORY**. You must answer the following questions:

If you have answered YES to any of the above questions:

- Inform your Pastoral Team by email, phone or in person if in FCF premises.
- If you are already at FCF premises, follow the instructions you are given, OR, if at home, stay home.
- Contact a doctor if you have concerns about your health.
- Temperature checks will be conducted at church should you feel unwell while you are at church



APPENDIX 1

MEMBER'S WAIVER:

I attest that:

- I am not experiencing any symptom of illness such as cough, shortness of breath or difficulty breathing, fever, chills, repeated shaking with chills, muscle pain, headache, sore throat, or new loss of taste or smell.
- I have not traveled internationally within the last 14 days.
- I have not traveled to a highly impacted area within Australia in the last 14 days.
- I do not believe I have been exposed to someone with a suspected and/or confirmed case of the Coronavirus/COVID-19.
- I have not been diagnosed with Coronavirus/Covid-19 and not yet cleared as non contagious by state or local public health authorities.
- I am following all Australian Government and NSW Health recommended guidelines as much as possible and limiting my exposure to the Coronavirus/COVID-19.

I hereby release and agree to hold Faith in Christ Fellowship harmless from, and waive on behalf of myself, my heirs, and any personal representatives any and all causes of action, claims, demands, damages, costs, expenses and compensation for damage or loss to myself and/or property that may be caused by any act, or failure to act of the church, or that may otherwise arise in any way in connection with any services received from Faith in Christ Fellowship. I understand that this release discharges Faith in Christ Fellowship from any liability or claim that I, my heirs, or any personal representatives may have against the church with respect to any bodily injury, illness, death, medical treatment, or property damage that may arise from, or in connection to, any services received from Faith in Christ Fellowship. This liability waiver and release extends to the church together with all pastors, elders, leaders, employees, and volunteers and other guests and their families.
